



# CONDITIONS OF ENTRY



## All patrons who enter a venue used for Boys & Girls FC by Football Victoria (a "Venue") are deemed to have acknowledged and accepted these Conditions of Entry:

Patrons are not permitted to bring the following items into the Venue:

- (a) alcohol or illicit drugs;
- (b) glass bottles, cans, metal containers or breakable containers;
- (c) flares, knives or offensive weapons, laser lights or anything that may be a potential missile or potentially cause an illegal or unlawful disturbance to players officials or spectators;
- (d) national and/or political flags (except for the recognised Australian national flag, State of Victoria flag, a Club flag or an FV flag) or offensive or inappropriate banners, slogans or emblems, whether in English or a foreign language;
- (e) subject to paragraph (d), flags, banners, emblems or slogans over 1.8 metres in length x 0.9 metres in width;
- (f) skateboards, scooters, rollerblades or bicycles;
- (g) dogs or other animals except for guide dogs and hearing animals;
- (h) marquees that cannot be pegged down (must be portable and/or able to be weighed down without pegs)
- (i) inflatable devices; and
- (j) any item that is deemed by FV, the host Club, the appointed Security Provider, agents acting on behalf of FV as potentially causing injury or a public nuisance or offence to any other user of the venue.

In addition:

- in caring for patron safety FV reserve the right to refuse entry to any person at their absolute discretion;
- there will be no serving of alcohol at the Venue;
- all persons' movements upon entering the Venue may be subject to monitoring by closed circuit television or other recording or photographic device, and any footage and/or images taken may be provided to FV who may provide such information to the responsible authorities (eg Victoria Police, FFA, and any other stakeholder at the FV's absolute discretion) and by entering the Venue a patron shall be deemed to have given consent to such monitoring and provision of such footage or images in accordance with this clause; persons entering the playing area without authorisation may be ejected from the Venue and may be prosecuted or banned from future matches in accordance with FV policy;
- patrons should be aware that sporting equipment such as footballs may be kicked or struck from the playing field into the seating or standing areas during events at any time;
- patrons choosing to leave valuables at the Venue do so at their own risk and neither the host Club, FV nor the venue management shall be responsible for any damage to or loss or theft of a patron's personal property;
- any items not permitted to be brought into the Venue may be confiscated by venue staff;
- patrons should note that children must be supervised by an accompanying adult at all times while in the Venue; some areas of the venue may be exposed to direct sunlight and heat. Patrons are required to take appropriate care of their sun protection and hydration;
- smoking is only permitted in designated areas of the venue. For assistance in locating these designated areas, please ask a member of the Venue's staff; and
- patrons must cooperate fully with all instructions issued by Victoria Police, venue security personnel, host Club staff or FV staff, and must provide accurate identification information to such persons if requested. Any identification details acquired may be provided to FV who may transfer the information to the responsible authorities (eg Victoria Police, FFA, and any other stakeholder at FV's absolute discretion). By entering the venue, a patron shall be deemed to have given consent to the transfer of identification information in accordance with this clause.

By entering this venue, or attending this event, you agree and are deemed to be bound by the terms of these Conditions of Entry, the FV GDT, and FV's member protection rules and policies. Any patron who breaches these conditions may be evicted from the venue and may be banned from attending future Boys & Girls FC events and all other FV sanctioned events as determined in accordance with FV policy.

The details of any persons asked to leave the venue by the host Club and/or FV, may be provided to FV, FFA or Victoria Police as required. FV may investigate and institute member protection proceedings in its sole discretion. The FFA, and any other stakeholder at FV's absolute discretion may also enforce the ban or subsequent penalty.
